COMMENCEMENT OF THE YEAR 2025 PROMOTION EXERCISE FOR OFFICERS ON SALARY GRADE LEVELS 06 - 13 UNDER THE COMMON POOL OF THE OFFICE OF THE ACCOUNTANT-GENERAL OF THE FEDERATION

Lam directed to refer to the above subject and to inform you that the Office of the Accountant-General of the Federation (OAGF) has commenced preparations for the conduct of the **Year 2025 Promotion Examination** for officers on Salary Grade Levels 06 – 13 who are within the common pool of the OAGF.

2. Accordingly, all Ministries, Departments and Agencies (MDAs) are kindly requested to submit briefs in respect of eligible officers in the OAGF pool as follows:

- For Officers on SGL 06 13: Vacancy Returns, Eligibility List, two (2) consecutive years' Annual Performance Evaluation Reports (APER), and one (1) year Performance Management System (PMS) score, for officers last promoted on or before 1st January, 2022.
- For Officers on SGL 03 05: One (1) year APER and one (1) year PMS score for officers last promoted on or before 1:t January, 2023.
- 3. The required data should be presented using the approved Excel template (both in soft and hard copies) and must bear the endorsement of the Director (Administration/Human Resource Management) of the submitting MDA. All submissions are to be forwarded to the Office of the Accountant-General of the Federation not later than Thursday, 23rd October, 2025, using the attached template.
- 4. For the avoidance of doubt, officers who are **not under the OAGF pool** shall only be considered upon the formal recommendation of the **Senior Staff**Committee (\$\$C) of their parent MDAs that belong to the **mainstream**Federal Civil Service. Officers from **autonomous Agencies** that recruit their own staff are **not eligible** under this arrangement.
- 5. It is the responsibility of Directors of Administration/Human Resource Management to ensure that all entries are **thoroughly verified and accurately presented** before submission, as they will be held **accountable** for the integrity of the information supplied.
- 6. You are kindly requested to give this circular prompt attention and ensure that the content are circulated to all concerned officers for necessary compliance.
