**YEAR 2025 SSC PROMOTION EXERCISE FOR ACCOUNT
OFFICERS ON SGL 06-13 UNDER THE POOL OFFICE OF
THE ACCOUNTANT-GENERAL OF THE FEDERATION
(OAGF)**

I am directed to refer to our earlier circular, Ref. No. **OAGF/ADM/2025/PROM/VOL.I/52** dated **13th October, 2025**, and to inform you that the Accountant-General of the Federation (AGF) has approved the time table for the conduct of the year 2025 SSC Promotion Examination/Interview for eligible officers on **Salary Grade Levels 07-13 in the pool Office of the Accountant-General of the Federation, who had their last promotion on or before 1/1/2022 and SGL 03-06, who had their last promotion on or before 1/1/2023, respectively.**

2. Below is the timetable for the Accreditation and Promotion Examination:

S/N	ACTIVITY	DATE AND TIME	VENUE
i.	Screening/Verification of eligible candidates for the examinations, Conversion/Upgrading in the HQ and six (6) zonal Centres. (To be held simultaneously)	Wednesday, 10th – Tuesday, 16th December, 2025	Wings A & B of the Treasury House and All 6 zonal Centres in: Kano, Gombe, Lokoja, Enugu, Benin, Ibadan
ii.	Accreditation and written Examination to hold simultaneously in all the centres.	Wednesday, 17th December, 2025	All 6 zonal Centres in: Kano, Gombe, Lokoja, Enugu, Benin, Ibadan and FCT (FTA Orozo).
iii.	Similarly, the Junior Staff Committee(JSC) Promotion for Officers on SGL 03-05 will take place concurrently on the same date, time and designated centres.		

3. **All eligible officers are to go to the Examination Centres within the geo-political zone of their duty posts** for the verification exercise as well as the promotion examination. Officers who fail to comply with this directive will not be verified and allowed to sit for the examination.

4. All officers are to present the original documents for sighting and one (1) set of photocopy of the following documents:

- i. Letter and Gazette of 1st Appointment;
 - ii. Letters of last three promotions;
 - iii. Gazette of Confirmation of Appointment;
 - iv. Birth Certificate/Declaration of Age;
 - v. Academic Certificates
 - vi. Professional Certificates **(Mandatory for Professional Accountants on SGL 13 and above)**
 - vi. NYSC Discharge Certificate/Exemption Certificate (if applicable)
 - vii. Letters of Regularization of Appointment (if applicable);
 - viii. Evidence of Conversion/Absorption (where applicable);
 - ix. Office Identity Card;
 - x. Two (2) most recent Passport Photographs; and
 - xi. Posting Instructions/Letter.
5. In addition, Candidates applying for **Conversion/Upgrading** are to present themselves at the screening/verification centres with photocopies of the following **documents** in six (6) sets in an envelope as indicated below;

- i. Letter and Gazette of 1st Appointment;
- ii. Letters of last two promotions;
- iii. Gazette of Confirmation of Appointment;

- iv. Birth Certificate/Declaration of Age;
 - v. Academic/Professional Certificates;
 - vi. Letters of Regularization of Appointment (if applicable);
 - vii. Evidence/approval to undergo course of study;
 - viii. Academic Certificates;
 - ix. NYSC Discharge Certificate/Exemption Certificate (if applicable);
- and
- x. Membership Certificate of approved professional body (where applicable);

NOTE: Officers who are not in the pool of the OAGF can only be considered for Conversion based on the recommendation of the Senior Staff Committee(SSC) of their respective MDAs that are in the mainstream of the Federal Civil Service, **not in Agencies** that have the autonomy to employ their own staff.

6. **For avoidance of doubt, the JSC Examination will also hold simultaneously with the SSC as indicated due to time constraint in paragraph 2 iii above.**
