
ROLLOUT AND IMPLEMENTATION GUIDELINES ON THE
ADOPTION OF THE REVENUE OPTIMIZATION (RevOP)
PLATFORM

In line with the ongoing fiscal reforms of the Federal Government and its commitment to improve visibility of revenue collections, enhance transparency, accountability, and efficiency in revenue value chain, the Federal Government of Nigeria is deploying the Revenue Optimization (RevOP) and Assurance Platform for real-time collection across all MDAs/FGOEs to ensure harmonised and unified technology-driven ecosystem.

2. In view of the above, the Federal Government is adopting a service-wide Revenue Optimization (RevOP) & Assurance Platform. Accordingly, RevOP is hereby recognized as the approved platform of the Federal Government end-to-end revenue optimization; providing unified automation of billing information, reconciliation, and treasury visibility. The platform shall further enable automated disbursement, revenue splitting, real-time monitoring of all Local and Foreign Currency Accounts maintained by MDAs/FGOEs and seamless integration with TSA, GIFMIS, CBN, NIBSS and FIRS systems and all revenue-collecting banks.

3. This Circular therefore, provides implementation guidelines for the operations of RevOP in which every MDAs/FGOEs shall:

- i. Nominate three (3) officers that will serve as RevOP focal personnel (one support officer and two Finance and Accounts staff, particularly revenue desk officers) not below and equivalent to Grade Level 10, and forward details to OAGF within seven (7) working days of this Circular;
 - ii. Ensure integration of all Enterprise Resource Planning (ERP)/Financial Systems currently in use by MDAs/FGOs with the RevOP Platform;
 - iii. Ensure that only CBN-licensed Payment Solution Service Providers (PSSPs) recommended by National Information Technology Development Agency (NITDA) and approved by the OAGF shall be allowed to provide the services listed in paragraph 2 above on behalf of MDA. MDAs are advised to ensure that all PSSPs currently providing billing information on their behalf connect with RevOP for instant harmonisation of Government collections on the platform. The process of profiling PSSPs shall commence and all approved PSSPs by the Treasury shall be recognised and listed on RevOP for collections;
 - iv. Provide OAGF with complete information on all Local and Foreign Currency Accounts maintained with commercial banks and Other Financial Institutions (where applicable);
 - v. Ensure compliance not later than 60 days from the date of this Circular, in liaison with the OAGF implementation team during onboarding and system adoption; and
 - vi. Contact the Director, Treasury Single Account Department, Office of the Accountant-General of the Federation for technical supports and further clarifications.
4. All Accounting Officers, Directors/Heads of Finance and Accounts and Internal Audit Departments/Units of MDAs and other Arms of Government are to give this Circular the widest circulation and ensure strict compliance, please.
