
2. It is important to emphasize that this Posting Instruction takes immediate effect and all handing/taking over processes must be completed **on or before Monday, 20<sup>th</sup> April, 2026.**

3. All officers concerned are reminded that failure to adhere to this Posting Instruction contravenes the provisions of the **Public Service Rule 100301 (b)** and will be met with severe sanctions.

4. Furthermore, any MDA that either deny the newly deployed Treasury Officers from assuming duties as contained in the Posting Instruction or prevent the redeployed officers from vacating their existing duty posts shall have their accounts and access right on both the GIFMIS application and Remita payment gateway blocked, and role players deactivated in accordance with Federal Treasury Circular **Ref. No HMFBNP/MDA;/FEDERAL TREASURY CIRCULAR/01/2023** dated **26th January,**

**2023** which was further re-echoed by Treasury Circular **Ref No: TRO/865/VOL.XVI of 8th November, 2023.**

5. Accordingly, the Director Administration, Office of the Accountant- General of the Federation, shall monitor compliance and ensure that all Treasury officers affected by this circular submit their Assumption of Duty Certificates to the Office of the undersigned **on or before Monday, 20<sup>th</sup> April, 2026.**
